OFFICIAL RULES OF SHOWCASE

- 1) Booth space includes ONE (1) six-foot folding table with cloth, and allows for TWO (2) chairs behind the table. No tables or displays are allowed to encroach into aisle or other booth space.
- 2) Maximum of TWO (2) persons allowed at a time at each booth.
- 3) No sharing of booth space without prior approval by ORGANIZER.
- 4) All food items/menus MUST be pre-approved by ORGANIZER and subject to rules and/or restrictions of the venue. Any vendor distributing edible products agrees to solely assume any and all liability and indemnify and hold harmless the ORGANIZER, the VENUE, and their agents and representatives for said products and their distribution .
- 5) No magazines, business cards, flyers, or other promotional materials from any other bridal show, business, or vendor may be distributed. Non-exhibitor materials are **not allowed**.
- 6) In the event of extreme weather or other situations beyond the control of the ORGANIZER and VENUE, the ORGANIZER will, at its sole discretion, reschedule the show. The ORGANIZER shall not be liable to any exhibitor for any loss or damage suffered by exhibitor by reason of such relocation or rescheduling of the show.
- 7) ORGANIZER reserves the right to restrict or refuse any vendor or number of vendors per business type to ensure the most positive product for the customers.
