Mayor Helms, Mr. Rush and Mr. Heath attended the Legislative breakfast this morning. It was very well attended and informative. There was a two hour session about opioids, transportations and budget. The Town Employee Christmas lunch will be December 7, 2018 at noon at the Holston Hills Community Golf Course. Town offices will be closed December 24 and 25, 2018 for the Christmas Holidays and January 1, 2019 for New Years. The garbage schedule will be advertised. Federal offices will be closed December 5, 2018 for a National Day of Mourning in observance of the death of the 41st President of the United States, George H. W. Bush. The Blue Ridge Job Corps lunch will be December 18, 2018. Mayor Helms noted Mr. Heath set up a meeting with Ballad Health to get a better understanding of the rumors about the Air Med Care and Hospitals changing their trauma levels. There were five Ballad Health care representatives present and the meeting was extremely informative and addressed concerns. Mr. Heath reviewed information on the Centre Building Resolution noting there is a correction to the code section.
